**All positions – Adult or Youth**

1. Must have email capability
2. Minimum age of 14 (and minimum age of 18 if authorized to sign contracts or acting as a signatory on Association accounts)

**Officer**

1. Must be a current GHUSBC board member and have served a minimum of two consecutive years on the BOD.

**YOUTH Director**

1. Youth – must have been a member of a GHUSBC youth league for the past 2 years; current year counts as one of the two.
2. Adult – must have been involved with the GHUSBC youth program either as a center youth director, coach, official, supervisor, representative, proprietor or center manager for the past 3 years; current year counts as one of the three.
3. **If age 18 or older, must be a Registered Volunteer before the start of their term.**

**As a Board Member of the Greater Houston USBC, you are required to work tournaments and serve on appointed committees. An average of ten board meetings are held per year and it is required that you attend these meetings. **If you are a new candidate, you must become a Registered Volunteer by the start of your term. Incumbents are required to be a Registered Volunteer currently.****
